## **NHTSA Safety Advisory: Little Passenger Seats**

A parent's priority is always to keep their child safe, and that includes making sure they are in the right car seat for their age and size, and to make sure that car seat meets Motor Vehicle Safety Standards (FMVSSs).


Through a concerned law enforcement officer, we learned about a vehicle seat on the market that claimed

to be FMVSS-certified, but was not. And while Little Passenger Seats (LPS) is no longer in business, the seats they made may still be available online. If you come across a car seat from the manufacturer, steer clear it poses a safety risk to your child.

- Rear-facing:
  - Weight of child: 4 50 lbs.
  - Lower anchor weight limit: 35 lbs.
- Forward-facing:
  - Weight of child: 22 65 lbs.
  - Lower anchor weight limit: 40 lbs.
- Harness height: 17 49 inches
  - 12-position, no-rethread harness

# Summer Affirm 335 - New Car Seat with 3 Pound Start Weight

- Rear-Facing Weight: 3-35 lbs.
  - Must have approval of the child's healthcare provider when used with premature, low birth weight, or medically fragile infants.
- Height: 15-32 inches
  - 4 Harness slot positions and 3 crotch buckle positions.
  - Infant body insert is optional for children from 3 11 lbs.
    - Insert is used when the harness is in the bottom 2 slots and the crotch buckle is in the inner or middle position.
- Chest clip designed as small as possible for a good fit for small babies.
- Secure the base with the Belt Tensioning Arm.
- Route the webbing through the blue belt guides and close the Belt Tensioning Arm.
  - Lock the seat belt to complete the installation when using the lap and shoulder belt.
- Angle the carrier handle toward the vehicle seat back to limit the amount of rebound movement experienced in a frontal-impact crash.

# **COVID-19 Update: CPST Recertification Extensions**

Safe Kids Certification continues to monitor the COVID-19 situation. To help ease recertification concerns, expiration dates from March 11-September 30 have been extended. Log into your online profile for your revised expiration date. Extensions:

- On March 11, every CPST with a March 11-June 15 certification expiration date was extended to June 30.
- On April 4, every CPST with a June certification expiration date (includes every tech in the first extension) was extended 4 months.

• On April 4, every CPST with a July, August or September certification expiration date was extended 3 months. If you are ready to recertify but can no longer do so due to the extension (more than 4 months away), please contact Safe Kids by email (<u>CPSCert@safekids.org</u>) or phone (202-875-6330). Your certification expiration date will be changed to the end of the month and you will be able to complete your recertification.

## **COVID-19 Class Precautions**

As Pennsylvania Counties move into the green phase, TIPP Staff are scheduling child passenger safety in-person update classes, and certification and renewal courses while following safety precautions. Staff will implement additional safety measures to better protect the health and well being of students.



Any student with questions on class safety protocol should contact the instructor listed for more information. The new policies include social distancing, less interaction between students and multiple vehicles, breaks and time for sanitizing work stations and hands. Any student that is uncomfortable with coming to class is welcome to wait for a future class or talk to instructors about virtual training opportunities.

### Lap & Shoulder Belts in School Buses

The National Association of State Directors of Pupil Transportation Services (NASDPTS) released a new positions paper, in May 2020, on the use of lap and shoulder (three-point) seat belts in school buses. This position paper provides guidance and assistance to professionals and policy makers charged with making the decision to require lap and shoulder belts on all new school buses.

NASDPTS fully supports requiring the installation and use of lap and shoulder belts in all new school buses. They further encourage States and local jurisdictions to have policies requiring all students to use the seat belts and that training be provided on how to use the seat belts properly. The training must include proper use and adjustment of seat belts, participation in regular evacuation drills that include unbuckling exercises. Prior to every field or activity trip, the school bus driver or other designated personnel must provide a safety briefing to all students and adult passengers that includes the required use of the belts, the location and use of emergency exits, and the location of emergency equipment.
